When used in this Supplement, **Prospectus Regulation** means the Regulation (EU) 2017/1129 of the European Parliament and of the Council, as amended, and the Commission Delegated Regulation (EU) 2019/980, as amended.

This Supplement constitutes a supplement to, and should be read in conjunction with, the Prospectus and the documents annexed to the Prospectus (see "Documents available" in the Prospectus).

The Issuer accepts responsibility for the information contained in this Supplement. To the best of the knowledge of the Issuer (which has taken all reasonable care to ensure that such is the case) the information contained in this Supplement is in accordance with the facts and does not omit anything likely to affect the import of such information.

Statements contained in this Supplement will to the extent applicable and whether expressly, by implication or otherwise, be deemed to modify or supersede statements incorporated in the Prospectus.

To the extent that there is any inconsistency between (a) any statement in this Supplement and (b) any other statement in the Prospectus, the statements in this Supplement will prevail.

Purpose of the Supplement

The purpose of this Supplement is to update the Prospectus regarding the expected timetable of the Offering and to make resulting changes to the Prospectus.

1. Update of the expected timetable of the Offering

By notices dated 20 January 2022, 31 May 2022 and 4 July 2022, the Management Board of the Issuer has announced amendments of the Offer Periods of the Prospectus. According to these notices, the First Offer Period lasted from 15 October 2021 to 17 June 2022, the Second Offer Period from 18 June 2022 to 7 August 2022 and the Third Offer Period from 8 August 2022 to 30 August 2022. In addition, the Management Board of the Issuer has resolved and announced by notice dated 19 August 2022 to leave the Offer Price per Offer Security for the Third Offer Period unchanged at EUR 7.50 per Offer Security (same as for the Second Offer Period).
